

What is *FastAttach*?

For large, multi-location practices, claims requiring attachments continue to be one of the main contributors to lengthy claim processing delays and claim denials. *FastAttach* improves revenue cycles by allowing providers to efficiently transmit x-rays, perio charts, EOBs, narratives, or any other documentation required by a payor to adjudicate a dental claim. *FastAttach* from NEA Powered by Vyne interfaces with most major practice management systems to streamline your office's revenue cycle by automatically populating claim data into *FastAttach*, eliminating the need for time consuming manual data entry.

FastAttach is HITRUST CSF Certified and facilitates the electronic exchange of information, which allows dentists to transmit all supporting claim documentation, via the Internet, to over 750 dental plans and payers in support of electronic claims.

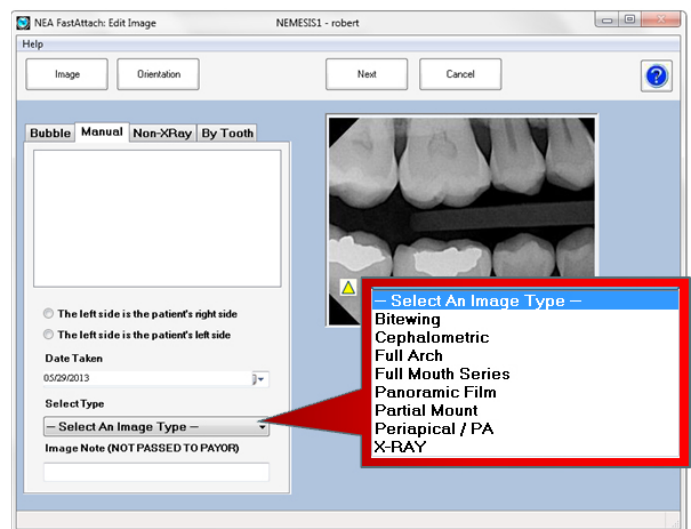
How does *FastAttach* work?

FastAttach is easy to setup and use. Once a request is received for additional documentation, the user simply needs to import, upload, scan or capture the image and attach it to the electronic request. *FastAttach* supports the widest variety of image acquisition methods in the industry including: screen capture, file import, scanner and secure mobile device capture through our *FastKapture* app for iOS® and Android®.

Once the image is captured in *FastAttach*, the practice simply transmits the image to the NEA repository. NEA immediately sends a report back to the practice with an NEA Attachment Tracking Number for each file. The practice places the NEA Tracking Number in the remarks or NTE section of the claim and sends the claim electronically through their claims clearinghouse.

Advantages for DSOs

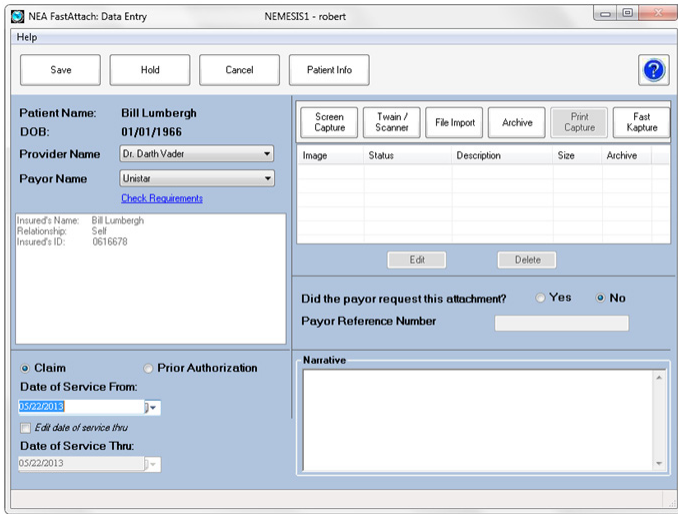

The Central Billing Office (CBO) features allow an office to send from a Master ID. The Master ID is a management tool that gives your practice choice to view patients, doctors & attachments from any branch facility within the DSO. Individual branches can create attachments, while the Master ID sends all attachments on behalf of each of their locations.



X-rays can be easily attached using FastAttach as can other required supporting documentation.

- Ability to view user/attachment activity for one or many locations
- Secure image and data sharing between *FastAttach* users
- *FastLook* verification tool allows users to verify payers' attachment requirements
